Wawa Announces Date for Pooler Grand Opening

Wawa Expansion in Georgia

Wawa opened its first stores in Georgia in 2024 in Bainbridge, Brunswick and Jesup. In 2025, Wawa will open 5-6 stores before year end. Over the next 5-8 years, Wawa plans to build and open more than 26 stores in Georgia, at the pace of around 3 to 4 stores per year. To build each store, Wawa will invest approximately \$7.5 million and employ, on average, 140 contractors and local partners. Once open, each store will employ an average of 35 associates, with Wawa expecting to create almost 900 long-term new jobs.
